- **After skin contact**  
After contact, clean the skin mechanical and rinse with water and soap.  
Change immediately contaminated clothes.

Rinse opened eye for several minutes under running water. If symptoms persist, consult doctor.
- **After swallowing**  
Drink copious amounts of water and provide fresh air. Instantly call for doctor.  
Show the pack or the label to the doctor.
